# Pharmacy Department

2021

This year has seen two of our staff achieve their PhD, one of our residents awarded the Victorian Resident of the Year and one of our Interns awarded an Honorable Mention – Hospital Pharmacy Award (one of three only awards provided amongst the cohort of approximately 180 interns statewide). Several new projects have been undertaken, including projects involving ten Monash University 4th year pharmacy students, that we expect to navigate to publication in 2022. The year ended with a total of 24 publications and several others submitted and undergoing peer review.

### Overview

#### **HIGHLIGHTS**

#### Two Doctorates achieved

Two of our pharmacists received their PhD this year, completing 6-7 years of work on a part-time basis. Dr Tim Tran received his PhD from Monash University for his thesis entitled "Expanding pharmacists' roles in medication management for surgical inpatients". Dr Phung To received her PhD from University of Melbourne for her thesis entitled "Improving the management of medications in patients with oral restrictions".

#### Resident pharmacists' success

Our two resident pharmacists, Natalie Thorp and James Ford presented their residency projects at the Victorian Resident of the Year heats run by the Society of Hospital Pharmacists of Australia in November. Natalie's project reported on medication transcription errors at the time of transfer from acute to subacute care. James' project evaluated the impact of hospital outreach medication reviews on reducing opioid use following joint replacement surgery. James was successful in reaching the national Resident of the Year Finals to be presented early in 2022. This will be the third time that the Resident of the Year awards have been held and, on each occasion, an Austin Health resident pharmacist has presented at the national final.

#### Intern pharmacists' project success

Six of our intern pharmacists presented their projects at the Monash University Intern Foundation Program presentation evening in November. One of our interns, Jasmin Pradhan, received the Honourable Mention – Hospital Pharmacy Award for her project: "Concordance of emergency department blood gas analyser and pathology laboratory potassium concentrations: implications for hyperkalaemia management". Jasmin was one of approximately 180 interns who presented, and she received one of three awards announced on the night.

#### Austin Health Research Fest and Pharmacy Research Forum

Pharmacy staff contributed to at least 18 of the 200 posters presented at Austin Health Research Fest in 2021, which is a significant effort! Following Research Fest, the pharmacy department held our third annual Research Forum at which staff and students presented some of the projects they had completed over the previous 12 months. Our pharmacy residents, interns and students had the opportunity to practice their presentations that they would later present at Monash University or SHPA forums and inform the pharmacy department of the projects that they had undertaken. We were fortunate enough to have Professor Mary O'Reilly, Acting Chief Medical Officer, attend the interns' presentations and contribute to some valuable and thought-provoking discussion.

#### **KEY PROJECTS COMPLETED IN 2021**

The following is only a selection of the breadth of projects that the department undertook in 2021. Several were published in 2021, and others are expected to be published in the coming year. Findings of these projects are informing future projects and advocacy within Austin Health, state-wide and nationally.

1. Access to medication administration orders and medication supplies at residential aged care facilities following transfer from hospital.

This was a multicentre project led by Austin Health pharmacists, A/Prof Rohan Elliott and Dr Simone Taylor. Data was collected by Monash University fourth year pharmacy students across ten Melbourne hospitals and involved over 150 residential aged care facilities (RACFs). Telephone interviews were conducted with RACFs around 72 hours after patients were discharged from a participating hospital.

The multicentre data is consistent with findings of our previous single site studies undertaken at Austin Health. When patients are discharged without a hospital prepared interim residential care medication administration chart, they are more likely to miss doses in the first 24-72 hours post-discharge. They are also more likely to require a locum general practitioner (who does not know the patient) to prepare their RACF long-term medication chart, rather than their usual general practitioner preparing the chart at a time that is more convenient to them.

This work has formed the basis of our discussions with the Australian Commission on Safety and Quality in Health Care as they update the national Guiding Principles of Medication Management in Residential Aged Care Facilities.

2. Enhancing pharmacists' roles in antimicrobial stewardship.

Sharmila Khumra is nearing completion of her Master of Pharmaceutical Science at Monash University on a part-time basis. In 2021, Sharmila published two papers related to her thesis. The first evaluated intravenous to oral antimicrobial switch in a hospital with a tightly regulated antimicrobial stewardship program (British Journal on Clinical Pharmacology 2021; 87: 3354–8). The second paper was a nation-wide survey that explored the practice, confidence, and educational needs of hospital pharmacists in reviewing antimicrobial prescribing (BMC Medical Education 2021; 21: 235. doi.org/10.1186/s12909-021-02664-1)

3. The CANBACK trial: a randomised, controlled clinical trial of oral cannabidiol for people presenting to the emergency department with acute low back pain.

Dr Michael Ching, Senior Pharmacist – Clinical Trials, was part of a collaboration with the emergency department to evaluate oral cannabidiol in acute back pain. This study was published in the Medical Journal of Australia (Med J Aust 2021; 214 (8): 370-375). Michael played a significant role in coordinating the logistics of access to this medicinal cannabis product and a corresponding placebo control, in addition to patient randomisation. The study found that cannabidiol was not superior to placebo as an adjunct for relieving acute non-traumatic low back pain in the emergency department.

4. Medication transcription errors associated with electronic prescribing during internal hospital transfers of care.

A problem with electronic medication management systems (eMMS) in Victoria, such as Cerner, is the discontinuation of medication charts during some internal hospital transfers of care (e.g. transfers from acute to subacute care). This is due to a technical requirement to separate encounter types for state funding purposes. A study conducted at Austin Health, by Senior Pharmacist - Aged Care, Nadia Mouchaileh, and Resident Pharmacist, Natalie Thorp, found that 65% of patients transferred from acute to subacute care encountered at least one medication transcription error.

This study has informed the development of a multicentre collaboration that will evaluate the prevalence and potential clinical impacts of these errors and medication administration delays in 2022. The study findings will be used to raise awareness of this problem with the Department of Health and Human Services, hospital administrators and eMMS managers, and inform the development of risk-mitigation solutions.

5. Medication management during Ramadan: a cross sectional study.

Ramadan fasting is one of five duties of Islam and involves abstinence from all food and drink from sunrise to sunset. Although there are exemptions from fasting, such as illness or taking medications, some Muslims with medical and surgical conditions choose to fast for a range of reasons. Our interest in exploring this issue stemmed from some patients refusing medication doses whilst in hospital, due to their fasting.

During Ramadan 2021, a linguistically and culturally diverse group of hospital pharmacists and Monash University fourth year pharmacy students interviewed Austin Health Muslim patients about their medication taking practices during Ramadan. This mixed methods study was led by Dr Phung To and Dr Simone Taylor, in collaboration with Iman Zayegh, a community pharmacist with expertise in advising patients about modifying their medication regimens during periods of fasting.

The study found that almost half of our Muslim patients fasted for Ramadan. Most of these patients altered their medication regimen to facilitate fasting, often without input from their healthcare professionals. Several patients reported having experienced medication-related adverse effects associated with altering their medication regimen, such as hypoglycaemia in diabetic patients. Patients reported diverse views and experiences around medication practices during Ramadan and past relationships with healthcare professionals influenced this practice. Participants asked that healthcare professionals partner with their Muslim patients to optimise medication management and health outcomes for Ramadan.

6. Evaluation of a novel advanced pharmacy technician role: discharge Medication Education Technician.

This project undertaken at Austin Health saw the development of a comprehensive training program to credential a hospital pharmacy technician (HPT) to provide discharge medication education to a defined group of surgery centre patients under indirect supervision of clinical pharmacists. (Journal of Pharmacy Practice and Research 2021;51(5):396-405). Upon completing the program, the HPT was designated a medication education technician (MEdTech). Consecutive overnight-staying patients were assigned to receive education by the MEdTech or pharmacists according to staff availability. Patient satisfaction with their education experience was measured via telephone calls the day following discharge.

Two hundred patients provided feedback (100 educated by the MEdTech and 100 by pharmacists). All patients reported high levels of overall satisfaction with their education experience, irrespective of which pharmacy staff member provided the education; a finding supported by the qualitative feedback.

This study supports advanced practice HPTs assisting with the provision of medication information to patients. This novel workforce model could facilitate pharmacists working in advanced-scope roles by having advanced HPTs undertake uncomplicated aspects of clinical pharmacy within a defined scope of practice and with specific pharmacist referral criteria.

#### LOOKING FORWARD

After a busy 2021 undertaking several new projects and some challenges in achieving timely peer review of submitted papers, we look forward to navigating several projects through to publication in the coming year. We also look forward to working with the staff in the Office for Research, led by their new Manager, Heidi Gaulke, as they undertake their significant work to update and streamline the organisation's ethical and governance review processes. A further goal for this coming year will be to develop collaborations with the newly formed Clinical Analytics and Reporting Unit (formerly Business Intelligence Unit) and Chief Pharmacy Informatics Officer, Christine Ting, to improve our data access and linkage capacity. The work of Phung To must be acknowledged, for her leadership in developing these relationships and capacity.
