## Overview

#### **HIGHLIGHTS**

This year has seen a further broadening of the range of themes for our research endeavours. In addition to our established areas of focus in aged care, emergency medicine, infectious diseases, oncology, pharmacovigilance and health services research, we congratulate Patrick Hilley on his work in the area of Inflammatory Bowel Disease. Patrick was successful in his application to the Melbourne Academic Centre for Health (MACH) to undertake a Health Services Research Fellowship.

Congratulations to Sharmila Khumra for completing her Master of Pharmaceutical Sciences with her thesis entitled: "Empowering hospital pharmacists to integrate antimicrobial stewardship into their daily practice." Sharmila's thesis builds on her many years of clinical expertise in infectious diseases and antimicrobial stewardship. Sharmila's thesis comprises three publications, that are testament to the rigor of a Master's degree undertaken by research. As noted in last year's report, Tim Tran completed his PhD in 2021, and this was awarded in March 2022.

Some twenty-three staff have authored one or more publications this year, many for the first time. Our department was very well represented at the SHPA Medicines Management conference this year, with fifteen abstracts presented as oral presentations or posters. Several of our interns presented their Intern Foundation Program research projects. Congratulations to Rachel Goodman for receiving one of three Monash University awards offered to the approximately 200 interns undertaking the Intern Foundation Program.

#### LOOKING FORWARD

Following the November conferences in 2022, we held our Pharmacy Department Research Planning Forum. To assist with selection of projects that are of importance to our department and the pharmacy profession more broadly, we used the Pharmacy Forecast Australia 2022 publication as a guide. Stemming from this, we are planning several projects in 2023 in the areas of sustainability, workforce development, provision of patient centred care, technology, funding models and workforce wellbeing.
