About Radiation Oncology

Austin Health is one of the largest cancer service providers in Victoria. A complete range of services are delivered to patients and their families, including medical oncology, clinical haematology, radiation oncology (Austin and Ballarat), cancer genetics, palliative medicine, wellness and supportive care programs, an active volunteer program an specialist cancer surgery. These are all provided in an environment that integrates research, teaching and training.

Austin Health has recently undertaken a major redevelopment of the physical facilities that Cancer Services are provided in. All of Austin Health metro based Cancer Services are now delivered within the Olivia Newton John Cancer and Wellness Centre (ONJCWC) at the Austin Hospital. This state of the art facility provides a new model of individualised cancer care for patients and their families.

The role of the Radiation Oncology Centre is to provide radiation oncology treatment services to patients with cancer. Established in 1992 the Radiation Oncology Centre provides a full range of treatment types to service the diverse needs of cancer patients. It is an innovative and progressive Radiation Oncology Centre located within the Olivia Newton John Cancer and Wellness Centre at the Austin Campus.

The Centre is equipped with three dual energy accelerators with high energy electrons, superficial and orthovoltage treatment machines and HDR brachytherapy. The treatment service is supported by two CT simulators and Elekta planning system (XiO and Monaco). The service provides a comprehensive program including IGRT, IMRT, and Stereotactic. It provides services to 1300 patients per year from the north-east region and country Victoria. The Centre provides a streamline service for veteran patients across the State of Victoria.

The Centre also provides true multidisciplinary service as part of the and directly provides a variety of nursing and allied health service to all patients in their care.

The Radiation Oncology Centre has a multidisciplinary team of 30-40 EFT. The Director provides clinical direction and leadership and is supported by the General Manager, RT Manager and Chief Physicist who coordinate all operational activities so that quality patient care is provided in a timely, and efficient manner.

- Participate in, and foster, quality research activities within the Department, Cancer Services and the Medical Centre
